Report from Treasurer - The Direct Appeal amount for non-playground purposes is very poor for this year. There will be no money for technology, but will allocate what is feasible for Earthbites and the library. The PAC will start replacing the playground in March with the monies that are raised

Presented the financial statement.

The PAC has \$130,058.48 in its chequing account, Gaming Account, and GICs. Currently, in the chequing account, there is \$52,781.69. In the Gaming account, there is \$11,703.16. The PAC received \$10,500 from the province on 9 October 2015. The PAC has to apply for the Gaming Grant, and receives \$20 per child enrolled in the school. The PAC invested \$65,000 last year in cashable GICs.

The Grad Account has \$1,511.98 as of 30 September 2015. There is a Legacy gift from the 2014 Graduating Class for a piece of equipment to be purchased for the Sensory Room in Liam Law's memory. It was never purchased, so Adele Tremblay is arranging it now. Otherwise, there should be no activity in this account until April or May of 2016. This account will have a separate Treasurer.

The Québec Exchange Account has \$1,461.55 in it as of 30 September. This account has a separate Treasurer, Janice Johnson.
